As you have had a referral to the Henry County Probation Department, you do have a juvenile delinquency record with Henry County. Pursuant to Indiana Code 31-39.8, you have the right to petition the Court to have your juvenile records expunged (destroyed)

"Any person may petition a juvenile court at any time to remove from:

- (1) the court's files;
- (2) the files of law enforcement agencies; and
- (3) the files of any other person who has provided services to a child under a court order; those records pertaining to the person's involvement in juvenile court proceedings."

If you chose to petition the Court to consider expunging your juvenile records, then this form is to be used. The Court would then review your request and determine whether or not the Court should grant the request.
